## Microsoft Office Specialist U.S. National Online Championship Contest Official Rules

**NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED.** CONTEST IS OPEN TO THE DIRECT AND INTENDED RECIPIENTS OF NCS PEARSON, INC. THAT ARE MICROSOFT OFFICE SPECIALISTS AND ARE RESIDENTS OF THE 50 UNITED STATES (EXCLUDING COLORADO AND MARYLAND) AND ARE NOT STUDENTS WITHIN THE CHICAGO PUBLIC SCHOOL DISTRICT.

## PARTICIPATION IN THIS CONTEST CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.

**BINDING AGREEMENT:** In order to participate in the Microsoft Office Specialist U.S. National Online Championship Contest (the "Contest"), you must agree to these Rules. Therefore, please read these Rules prior to participating to ensure you understand and agree. You agree that participating in the Contest constitutes your agreement to these Rules. You may not participate in the Contest and are not eligible to receive any prize described in these Rules unless you agree to these Rules. These Rules form a binding legal agreement between you and Sponsor with respect to the Contest.

**CONTEST ELIGIBILITY:** To be eligible to participate in the Contest, you must: (1) have taken a qualifying Microsoft Office Specialist Office (MOS) exam between June 16, 2019 and May 14, 2021; (2) have been over 13 years old at the time you took the qualifying exam; (3) have been under 22 at the time you took the qualifying exam; (4) if you are an eligible minor you must have the permission from your parents or legal guardians to participate in the Contest; (5) be enrolled in an approved academic institution (as defined by Sponsor in its sole discretion); (6) not be a resident of Colorado or Maryland; (7) not be a student at a school within the Chicago Public School District; (8) have access to the Internet as of June 15, 2019 Contest is void in Colorado and Maryland and where prohibited by law. Students attending Chicago Public Schools are ineligible. Employees, interns, contractors, and official office-holders of Sponsor, NCS Pearson, Inc., Microsoft, Inc., Certiport, Inc., and their respective parent companies, subsidiaries, affiliates, and their respective directors, officers, employees, advertising and Contest agencies, representatives, and agents (collectively, "Contest Entities"), and members of the Contest Entities immediate families (parents, siblings, children, spouses, and life partners of each, regardless of where they live) and members of the households (whether related or not) of such Contest Entities are ineligible to participate in this Contest. Sponsor reserves the right to verify eligibility and to adjudicate on any dispute at any time. Entrants who have previously competed in a Microsoft Office Specialist U.S. National Championship final round are not eligible to compete in the same product track (e.g. Excel, Word, or PowerPoint) for the 2021 Microsoft Office Specialist U.S. National Online Championship, even if it is a different version of that product, but may compete in a different product track (e.g. a previous competitor in the Excel product track can only compete in the Word or PowerPoint product tracks).

**CONTEST PERIOD:** The contest period will take place online at

https://gocertiport.pearsonvue.com/MOSNationalOnlineChampionship (the "Event) and begins on June 16, 2019 at 12:00 AM Mountain Time (MT) Zone in the United States and ends on May 14, 2021 at 11:59 PM MT ("Contest Period"). PARTICIPANTS ARE RESPONSIBLE FOR DETERMINING THE CORRESPONDING TIME ZONE IN THEIR RESPECTIVE JURISDICTIONS.

HOW TO PARTICIPATE IN THE CONTEST: During the Event, eligible entrants may take and submit a qualifying Microsoft Office Specialist Office (MOS) exam. The six (6) qualifying Microsoft Office Specialist exams include: (i) Microsoft Word (Office 2016) (formerly known as MOS 2016 Word); (ii) Microsoft PowerPoint (Office 2016) (formerly known as MOS 2016 Excel); (iv) Microsoft Word (Microsoft 365 Apps and Office 2019) (formerly known as MOS 2019 Word); (v) Microsoft PowerPoint (Microsoft 365 Apps and Office 2019) (formerly known as MOS 2019 PowerPoint); or (vi) Microsoft Excel (Microsoft 365 Apps and Office 2019) (formerly known as MOS 2019 Excel).

WINNER DETERMINATION: At the conclusion of the Contest Period, a team of judges will review all qualifying exam submissions. The one (1) exam that receives the highest overall score in each qualifying MICROSOFT OFFICE SPECIALIST exam will be deemed a potential First Prize winner (for a total of six (6) potential First Prize winners). The one (1) exam that receives the next highest overall score in each qualifying MICROSOFT OFFICE SPECIALIST exam will be deemed a potential Second Prize winner (for a total of six (6) potential Second Prize winners). The one (1) exam that receives the next highest overall score in each qualifying MICROSOFT OFFICE SPECIALIST exam will be deemed a potential Third Prize winner (for a total of six (6) potential Third Prize winners). In the event of a tie, the entrant that completed the applicable MICROSOFT OFFICE SPECIALIST exam in the shortest amount of time (as determined by Sponsor, in its sole discretion) will be selected as the potential winner of the applicable MICROSOFT OFFICE SPECIALIST exam. In the event a potential winner is disqualified for any reason, the exam for the applicable MICROSOFT OFFICE SPECIALIST Exam that received the next highest total score will be chosen as the potential winner.

WINNER NOTIFICATION: On or about May 19, 2021 the potential winners will be announced via email. If a potential winner does not respond to the email notification within 72 hours after it being received, then such potential winner may be disqualified and an alternate potential winner may be selected from among all eligible exams received based on the winner procedure described herein. Except where prohibited by law, each potential winner will be required to sign and return a Declaration of Eligibility and Liability and Publicity Release and provide any additional information that may be required by Sponsor. Potential winners must return all such required documents within three (3) days following attempted notification or such potential winner will be deemed to have forfeited the prize and another potential winner may be selected based on the winner procedure described herein. All notification requirements, as well as other requirements within these Rules, will be strictly enforced. In the event that no entries are received, no prize will be awarded. Determinations of Sponsor are final and binding.

**WINNER ANNOUNCEMENT:** On or about June 23, 2021, the sponsor will publicly announce the 2021 MICROSOFT OFFICE SPECIALIST U.S. National Online Champions at an awards ceremony that will be held online.

SIX (6) FIRST PLACE PRIZES (One (1) per applicable MICROSOFT OFFICE SPECIALIST Exam): A scholarship awarded in the form of a \$3,000 USD check. Approximate Retail Value ("ARV") of each Microsoft Office Specialist First Place Prize: \$3,000 USD. In the event that the Sponsor holds the 2021 Microsoft Office Specialists World Championships (World Championships) in a live in-person format, each First-Place winner will be invited to participate in the World Championships, subject to the rules of the World Championships. If the winner chooses to participate in the live in-person World Championships, Sponsor will provide airfare and lodging to and from the World Championships for the First-Place winner and a single chaperone (if winner is a minor). In the event that the Sponsor holds the World Championships in an online format, each First-Place winner will be invited to participate in the online World Championships, subject to the rules of the World Championships.

**SIX (6) SECOND PLACE PRIZES (One (1) per applicable MICROSOFT OFFICE SPECIALIST Exam):** A scholarship awarded in the form of a \$1,500 USD check. Approximate Retail Value ("ARV") of each Microsoft Office Specialist Second Place Prize: \$1,500 USD.

**SIX (6) THIRD PLACE PRIZES (One (1) per applicable MICROSOFT OFFICE SPECIALIST Exam):** A scholarship awarded in the form of a \$750 USD check. Approximate Retail Value ("ARV") of each Microsoft Office Specialist Third Place Prize: \$750 USD.

**PRIZE CONDITIONS:** No transfer, substitution or cash equivalent for prizes is allowed, except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize, in whole or in part, of equal or greater monetary value if a prize cannot be awarded, in whole or in part, as described for any reason. Contest Entities have not made and Contest Entities are not responsible in any manner for any warranties, representations, or guarantees, express or implied, in fact or law, relating to the prize, regarding the use, value or enjoyment of the prize.

PRIVACY: Participant acknowledges and agrees that Sponsor may collect, store, share and otherwise use any personally identifiable information provided to Sponsor throughout the Contest, including, but not limited to, name, mailing address, date of birth, email address, and any financial information collected to facilitate awarding any applicable prize. Participant's information may also be transferred to countries outside the country of participant's residence, including the United States. Such other countries may not have privacy laws and regulations similar to those of the country of participant's residence. To the maximum extent permitted by law, each participant agrees to defend, indemnify and hold harmless the Contest Entities from and against any and all claims, actions, suits or proceedings, as well as any and all losses, liabilities, damages, costs and expenses (including reasonable attorney's fees) arising out of or accruing from (a) any exam or other material uploaded or otherwise provided by the participant that infringes any copyright, trademark, trade secret, trade dress, patent or other intellectual property right of any person or defames any person or violates their rights of publicity or privacy, (b) any misrepresentation made by the participant in connection with the Contest; (c) any non-compliance by the participant with these Rules; (d) claims brought by persons or entities other than the parties to these Rules arising from or related to the participant's involvement with the Contest; (e) acceptance, possession, misuse or use of any prize or participation in any Contest-related activity or participation in this Contest; (f) any malfunction or other problem with the Contest Site; (g) any error in the collection, processing, or retention of exam information; or (h) any typographical or other error in the printing, offering or announcement of any prize or winners.

**ELIMINATION:** Any false information provided within the context of the Contest by any participant concerning identity, previous participation in any MICROSOFT OFFICE SPECIALIST U.S. National Championship, mailing address, telephone number, email address, ownership of right or non-compliance with these Rules or the like may result in the immediate elimination of the participant from the Contest.

**INTERNET:** Contest Entities are not responsible for any malfunction or for any late, lost, damaged, misdirected, incomplete, undeliverable, or destroyed exams due to system errors, failed, incomplete or garbled computer or other telecommunication transmission malfunctions, hardware or software failures of any kind, lost or unavailable network connections, typographical or system/human errors and failures, technical malfunction(s) of any telephone network or lines, cable connections, satellite transmissions, servers or providers, or computer equipment, traffic congestion on the Internet or at the Contest Site, or any combination thereof, including other telecommunication, cable, digital or satellite malfunctions which may limit an participant's ability to participate.

RIGHT TO CANCEL, MODIFY OR DISQUALIFY. If for any reason the Contest is not capable of running as planned, including, without limitation, due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Contest, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest and if terminated, Sponsor will determine the potential winners for the Contest from among all eligible exams received prior to action taken using the judging criteria specified above. Sponsor further reserves the right to disqualify any participant who tampers with the submission process or any other part of the Contest or Contest Site. Any attempt by an participant to deliberately damage any web site, including the Contest Site, or undermine the legitimate operation of the Contest is a violation of criminal and civil laws and should such an attempt be made, Sponsor reserves the right to seek any and all remedies available from any such participant to the fullest extent of the applicable law.

**FORCE MAJEURE.** Sponsor will not be liable, and will be excused from performance, for failure or delay to perform obligations of this Contest, which have become practicably impossible because of circumstances beyond the reasonable control of the Sponsor. Such circumstances include without limitation natural disasters or acts of God; fires; storms; floods; riots; earthquakes; acts of terrorism; labor disputes or stoppages; government acts or orders; epidemics; pandemics or outbreak of communicable disease; quarantines; national or regional emergencies; insurrection; civil disturbance; sabotage; embargos; blockades; acts of war; power failure; failure of Internet access or service communication line failures; or any other cause whatsoever beyond Sponsor's control, whether similar in kind to the foregoing or otherwise. Sponsor will provide email notice of delay, termination, or modification of the Contest format/rules or any other responsibilities of the Sponsor due to force majeure to the Participant no later than ten (10) business days following the

force majeure event commencing, which notice shall describe the force majeure event and the actions Sponsor is taking regarding the Contest (e.g. postponing, cancelling, moving location, going digital, etc.).

**NOT AN OFFER OR CONTRACT OF EMPLOYMENT:** Under no circumstances shall the submission of an exam into the Contest, the awarding of a prize, or anything in these Rules be construed as an offer or contract of employment with either Sponsor, or the Contest Entities. You acknowledge that you have submitted your exam voluntarily and not in confidence or in trust. You acknowledge that no confidential, fiduciary, agency or other relationship or implied-in-fact contract now exists between you and Sponsor or the Contest Entities and that no such relationship is established by your submission of an exam under these Rules.

**FORUM AND RECOURSE TO JUDICIAL PROCEDURES:** These Rules shall be governed by, subject to, and construed in accordance with the laws of the State of Minnesota, United States of America, excluding all conflict of law rules. If any provision(s) of these Rules are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect. To the extent permitted by law, the rights to litigate, seek injunctive relief or make any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Contest are hereby excluded, and all Participants expressly waive any and all such rights.

ARBITRATION; WAIVER OF CLASS ACTION. By entering the Contest, you agree that any dispute arising out of or relating to the Contest or these Rules, including without limitation federal and state statutory claims, common law claims, and those based in contract, tort, fraud, misrepresentation or any other legal theory, shall be resolved through binding arbitration, on an individual basis (the "Arbitration Agreement"). All disputes between you and Sponsor of whatsoever kind or nature arising out of these Rules shall be submitted to Judicial Arbitration and Mediation Services, Inc. ("JAMS") for binding arbitration under its rules then in effect in Minnesota, before one arbitrator to be mutually agreed upon by both parties. The parties agree to share equally in the arbitration costs incurred. This Arbitration Agreement includes, without limitation, disputes arising out of or related to the interpretation or application of the Arbitration Agreement, including the enforceability, revocability, scope, or validity of the Arbitration Agreement or any portion of the Arbitration Agreement. All such matters shall be decided by an arbitrator and not by a court or judge.

CLASS ACTION WAIVER: TO THE EXTENT PERMISSIBLE BY LAW, ALL CLAIMS MUST BE BROUGHT IN THE PARTIES' INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS, COLLECTIVE ACTION, OR REPRESENTATIVE PROCEEDING (COLLECTIVELY "CLASS ACTION WAIVER"). THE ARBITRATOR MAY NOT CONSOLIDATE MORE THAN ONE PERSON'S CLAIMS OR ENGAGE IN ANY CLASS ARBITRATION. YOU AGREE THAT, BY ENTERING THE CONTEST, YOU AND SPONSOR ARE EACH WAIVING THE RIGHT TO A TRIAL BY JURY AND THE RIGHT TO PARTICIPATE IN A CLASS ACTION
